Enclosed you will find a copy of Resolution No. 2005-86, signed September 6, 2005. This resolution stated our support for a community supported Bikeway. It also asks that your group work with local land holders and industries to identify a safe route and areas of concern.


We continue to support the "Share the Road" program to encourage joint use of Chelan County roads. It is our concern that the current route you have identified involves a number of dangerous areas and appears to have been chosen without involvement of the neighbors who also use that route. To add signage promoting it as a "safe" bike route without improvements is problematic.

Again, we encourage your group to reach out to the community to jointly identify a route and improvements that would truly make the loop a safe route for the bicycling community.
